

SFT Gov't Money Market Liquidity and Net Fund Flows

The following report provides the percentage of the daily and weekly liquid assets and fund flows for the Fund for a rolling six month period.

Rule 2a-7 of the Investment Company Act of 1940 provides that money market funds may not acquire any security other than a "weekly liquid asset" unless, immediately following such purchase, at least 30% of its total assets would be invested in weekly liquid assets. In addition, the Rule provides that taxable money market funds may not acquire any security other than a "daily liquid asset" unless, immediately following such purchase, at least 10% of its total assets would be invested in daily liquid assets.

The percentage of the daily and weekly liquid assets of the Funds may change from day to day.

Daily liquid assets include (i) cash; (ii) direct obligations of the U.S. Government; (iii) securities that will mature or are subject to a demand feature that is exercisable and payable within one business day; or (iv) amounts receivable and due unconditionally within one business day on pending sales of portfolio securities. The requirement to maintain Daily Liquid Assets does not apply to tax exempt funds.

Weekly liquid assets include (i) cash; (ii) direct obligations of the U.S. Government; (iii) government securities issued by a person controlled or supervised by and acting as an instrumentality of the government of the United States pursuant to authority granted by the Congress of the United States, that are issued at a discount to the principal amount to be repaid at maturity and have a remaining maturity of 60 days or less; and (iv) securities that will mature or are subject to a demand feature that is exercisable and payable within five business days.

The percentage of the daily and weekly liquid assets of the Fund are presented as a percentage of the Fund's total assets as of market close.
